iv	Details of the violation(s)/contravention(s) committed or alleged to be committed	The GSPCB based on their analysis of the water samples drawn in and around Goa unit, has alleged that elevated levels of Total Kjeldahl Nitrogen (TKN) and Potassium are present in the sample as they are constituents in the Products manufactured by the Company."
		The Company firmly disputes these allegations and has provided legitimate reasons for the observed conditions. However, in compliance with the directive the Company has deposited an amount of Rs. 12,37,500/- as compensation in accordance with the Polluter's pay principle while it continues to contest the GSPCB's findings.
